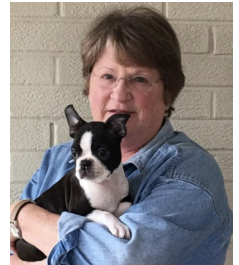

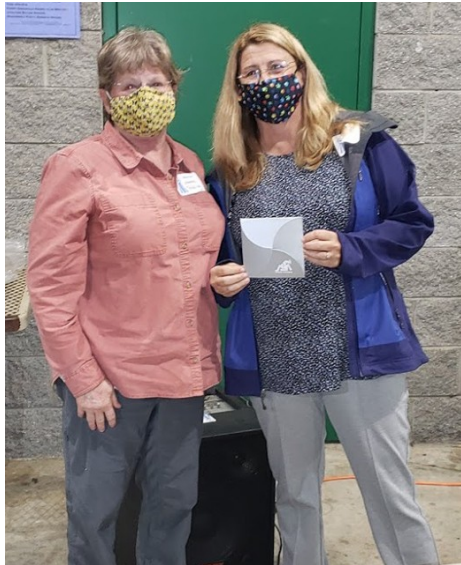

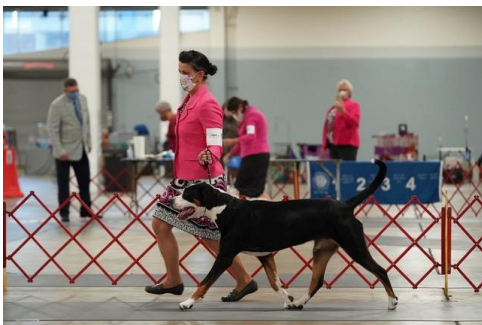
After receiving 3 back to back major wins in Tennessee last month,

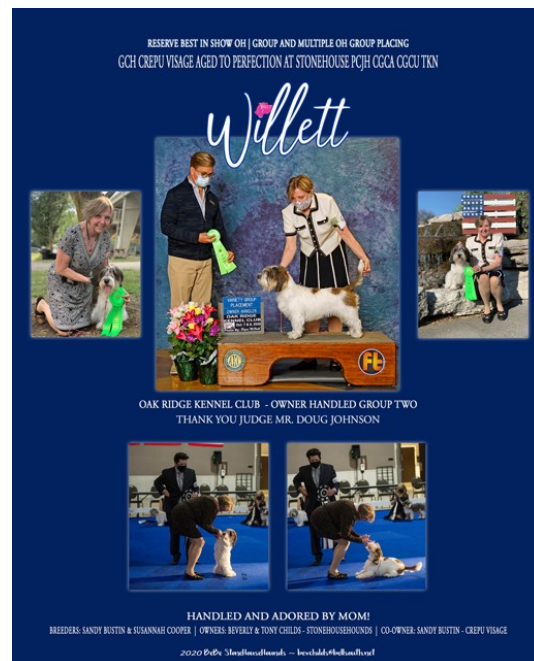
**Beverly and Tony Childs and the StoneHouseHounds**

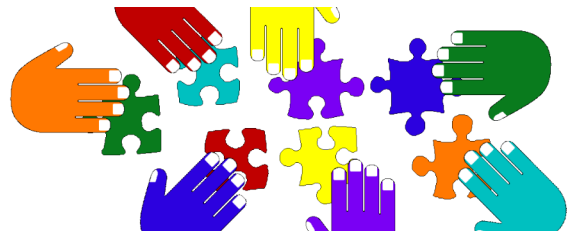
