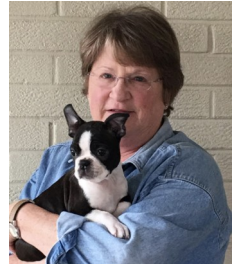

This gave her 2 more points towards her championship!

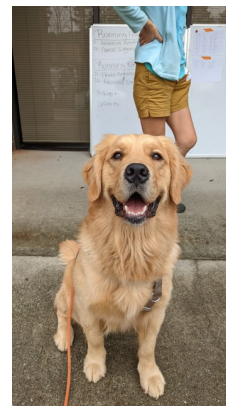
