He also earned Trick Dog Titles in Novice and Intermediate.

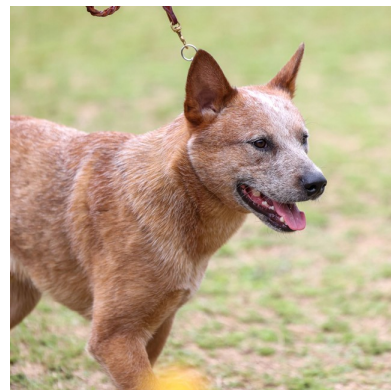
